



STUDENT SATISFACTION SURVAY



Among the 1,302 survey respondents, the majority were Bachelor's students (55.8%), followed by Associate degree students (23.7%). Other academic levels, including BTEC, Foundation, Master's, and PhD, had notably lower representation, each accounting for less than 1%. This distribution reflects the institution's predominantly undergraduate student population and will help guide targeted improvements based on the feedback received.



SUMMARY

The survey gathered 1,076 responses from students at different academic levels, providing a broad and diverse set of perspectives. The findings reveal a generally positive outlook on education quality and the learning environment, but also highlight key areas needing improvement, such as parking, student-faculty engagement, campus hygiene, and communication effectiveness.

Overall, 83.02% of students expressed their willingness to recommend MCBS to others, and 86.34% were satisfied with the quality education. Faculty members were commended for their dedication and teaching methods. and many students praised the supportive and welcoming environment that MCBS fosters.

GENDER BREAKDOWN

Survey results show a higher female participation rate, with 61.45% female and 38.55% male respondents, indicating stronger engagement from female students.

The initial meeting on March 3, 2025, focused on clarifying establishing communication channels, and identifying priority areas for action. These include enhancing awareness and understanding quality assurance processes. supporting data-informed decisionand contributing making, documentation practices required under the OAAAOA Institutional Standards Assessment (ISA) framework.

The Circle is also positioned to assist in promoting internal alignment with strategic objectives and external benchmarks bv contributing of periodic reviews institutional performance and providing feedback the effectiveness of quality initiatives. It will play a supporting role in activities such as internal audits. stakeholder feedback collection, and process mapping.

As MCBS advances its quality agenda, the Quality Circle will serve as a key enabler of institutional learning and improvement. The IRQA department encourages broad engagement with this initiative and welcomes contributions that help embed a culture of quality into the daily practices of the College.

CAPACITY BUILDING WORKSHOPS

The workshop emphasized the use of direct and indirect assessment tools, data interpretation, and the integration of findings into curriculum improvement cycles.
